### Information collection

We may collect and process the following information about you:

- (1) your email address and IP address.
- (2) pictures and other information from your device's camera and photo library.
- (3) device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- (4) the type, version, brand, language and operating system of device.
- (5) the pages of the App that you visit, the time and date of your visit, the time spent on those pages.

### Use of information

The purposes for which information may be used by us in include:

- (1) providing Services offered through the App.
- (2) contacting you in response to a guery or suggestion.
- (3) our operations, e.g., incorporation into our database, analysis, research and auditing.
- (4) prevention or detection of crime, and protection of the security and safety of our system.
- (5) complying with laws and regulations.

### Disclosure of information

We will keep the personal data we hold confidential but may provide your personal data to:

- (1) our affiliates.
- (2) personnel, agents, advisers, auditors, contractors and service providers in connection with our operations of the App.
- (3) persons or government organizations to whom we are required to make disclosure under applicable laws.

#### Children or minors

The App does not address anyone under the age of 13 years old ("children or minors"). We do not knowingly collect personally information from children or minors. If you are a parent or guardian and you are aware that your child has provided us with personal data, please contact us. If we become aware that we have collected personal data from children or minors without verification of parental consent, we take steps to remove that information from our servers.

### Your data privacy rights

You have the right:

- (1) to check whether we hold personal data about you and to access such data.
- (2) to require us to correct inaccurate data.
- (3) to request access to and rectification or erasure of your personal data.
- (4) to obtain restriction of processing or to object to processing of your personal data; and
- (5) to the right to data portability.

#### Retention

We will retain your personal information as long as we need to fulfill the purposes outlined in this Policy unless a longer retention period is required or permitted by law, or unless the information is deleted pursuant to the exercise of your rights. We will take reasonable steps to destroy or permanently de-identify personal information if it is no longer needed for such purposes.
